This Memorandum of understanding (MoU) agreement is executed on this

#### **BETWEEN**

Ms. Jisha P.V daughter of sri. K. Balan Nair, Head, PG Department of Commerce , **Nehru Arts and Science College, Kanhangad**, now residing at Kanathilhouse, Kollampara P.O. Nileswar, Kasargod, 671314 on the first part (here in after called as first party)

#### **AND**

Mr. Mathew M.J son of Joseph, Head, PG Department of Commerce, **Navajyothi college Cherupuzha**, now residing at Maleparambil house Mannattikavala, Mandapam P.O., Chittarikkal via, Kasargod -671326 on the second part (here in after called as second party)

Whereas the first party who is the head of the PG department of Commerce and authorized representative of Nehru Arts and Science College, Kanhangad an aided college run by Nehru Memorial educational society has expressed her willingness to the second party who is the head of the PG Department of Commerce and authorized representative of Navajyothi College Cherupuzha.

To establish relation between the two educational institutions to enhance the mutual co-operation between the researchers of the selected projects in both the colleges and to co-operate with each other in the process of inculcating higher level knowledge and sharing resources and experiences in the areas of research for the benefit of students of both the institutions. They may include the organization of a joined seminar or workshop or experts visit.

And whereas the second party has accepted the proposal believing that the academic tie-up between the institutions would foster and support the research projects and academia from both the colleges for joint co- development of innovative projects or services. This agreement for the academic tie up between the institutions for a period of three years from the date of this agreement upon the terms and conditions herein after mentioned.

#### **Now the Memorandum of understanding witnesses as follows:**

1. The purpose of this MoU is to develop academic and co-operation and to promote mutual understanding between the two educational institutions.
2. Both Institutions agree and shall endeavour to promote collaborative activities in academic and research areas of mutual interest on the basis of equality and reciprocity.
3. Utilise the service and expertise of the teachers and the researchers of the respective colleges for mutual benefit.
4. It is agreed to create a structured forum for peer-to-peer interaction, experience sharing and exchange of views among the faculty and students for better networking and synergy.
5. Exchange of students- graduate and undergraduate to attend classes, seminars, workshops conducted by the two Institutions.
6. The Terms of Co-operation for each specific activity implemented under the MoU shall be mutually discussed and agreed upon by both the party.
7. The teachers of one institution invited for classes in the other institution as part of this MoU will be paid travel expenses and remuneration at the rate mutually agreed-upon.
8. Now, the financial commitments what so ever, on the part of either signatory to this, MoU is either intended or implied.



9. This MoU shall remain in force for a period of three years from the date of this agreement and shall be renewed for a further period on mutual consent of the party.
10. Each institution shall designate a liaison officer to develop and co-ordinate the specific activities agreed upon.

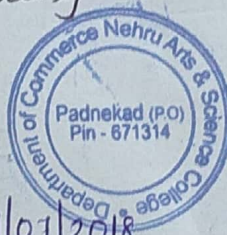
